

### Highlight of Water Seminar & Gujarat Water Summit 2011

The 4th edition of Gujarat Water Summit was held on 16th July, 2011 at Ahmedabad, with the joint efforts of the Confederation of Indian Industry and the Water Supply Department, Government of Gujarat. This summit, along with an Expo, was organized as part of the pre-summit seminars organized in Gujarat in the run-up to the Vibrant Gujarat event. As part of this Summit, the CII TATA Strategic Management Group Report on "Partnerships for Sustainable Water Management" was released.

During the day long seminar, various stakeholders presented their viewpoints on the challenges facing the water sector. The discussions and presentations focused on the current issues and dwelt on potential solutions to meet some of the challenges plaguing this sector. The report, released as part of this event, focused on supply side and demand side issues for the water sector. The report provided an overview on some of the technological solutions and business models (like PPP) that are evolving in this sector. The Seminar was attended by a number of delegates from large and medium water sector enterprises in Gujarat, government officials, end-user industries and key stakeholders of the sector.





### Water Seminar and Gujarat Water Summit 2014 Background

The current scenario for water availability in the country is a matter of concern for the key stakeholders. While the demand for water resources has grown at a rapid pace, the availability of water has undergone a steep decline. This situation is poised to worsen in the coming years, leaving many end-users starved of water. Such a scenario of severe water shortages could lead to a potential business continuity risk for industries, in particular. This could result in revenue losses to the tune of several crores for the industry players and the Government. Thus, the need for sustainable practices of water management is the need of the hour.

The thrust towards sustainable water management can only be achieved by a concerted push by the key stakeholders Industries and Government. A sustained commitment towards reducing freshwater consumption, investing in water recycling and reuse, and practicing water optimization techniques, needs to be pursued by the water users in the future. These measures would need to be complemented by the introduction of new technologies and business models, geared to meet the challenges of the water sector. Successful execution of these measures would go a long way in mitigating the coming water challenges and ensuring availability of sufficient water supplies in the future.

Thus the theme... "Securing our Water Future"

The Water Seminar and Gujarat Water Summit 2014 would address some of these key topics and act as a platform for sharing of ideas and dissemination of information on best practices, being pursued in the water space.

This year's Summit aims to focus on various water related issues and suggest possible solutions. It will provide a platform for service providers to offer state-of-the-art technologies, products & services vis-à-vis rain harvesting, recycling of waste water, supply & distribution, water treatment & filtration, sea water desalination etc. Sharing of best practices being followed by leading industry players would provide an opportunity for other companies to adopt these practices and reap the rewards of greater water security. The Summit will also provide a unique opportunity to bring all the stake holders together i.e. the government, local municipal corporation, industry, academic & other institutions and consumer groups to discuss possible integrated solutions pertaining to water management. Active participation of the interested organizations, Govt. and private institutions is solicited for success of the proposed international seminar.
