




Prime Minister of India has also mentioned in his speech that open defectation is a national shame. At the same time to make entire country open defection free we need a great workforce of young professionals. Every year thousands of students graduated as Engineers and Doctors or social workers out of which very few make their career on WASH.

There has always been a vacuum in this sector in terms of trained WASH professionals as in India we do not offer such customized courses. Largely professionals come from civil, environment, public health, social sector and there has always been a debate whether WASH to be managed by engineers or public health professionals. But, ideally we need a mix and it is very difficult to get a balance skill under conventional teaching programme in India.

Under this background UNICE Mumbai, along with Tata Institute of Social Sciences took the decision developing a dedicated full time course on WASH and launched the first ever Post Graduate Diploma in Water, Sanitation and Hygiene (PGD-WASH) in India. The aim of this programme is to create a group of professionals who can act as a knowledge manager between the Government/CSO and community to plan and implement sustainable solutions improving safe and improved access on sanitation and drinking water to each and every household.

This is my sincere request to the visiting organizations to give these young guns of India a chance to grow and prosper under your leadership and guidance.



TISS Tuljapur was conceived as a rural campus in 1986, as part of the Institute's Golden Jubilee initiatives towards holistic and sustainable development The Government of Maharashtra donated 100 acres of barren land in Sindphal village, Tuljapur Taluka, Osmanabad District for this purpose. In the first phase commencing in 1988, community action projects were initiated and linkages built with rural communities. The nature of these projects-making the EGS work for the poor, mobilisation of women and marginalised communities to access services, demonstration of the watershed project, integrating gender and equity aspects, facilitation of community participation in reconstruction and rehabilitation of earthquake-affected people and training of police, block development and local level officials-provided TISS Tuliapur a solid base in the region. The sprawling Tuliapur campus is now a beautiful green campus with excellent infrastructure. It currently offers Post Graduate Diploma in Water Sanitation & Hygiene (WASH), Five-year integrated master's degree programme in Social Sciences, M.A., M. Phil and Ph.D. in Social Work with specialisation in Rural Development. TISS Tuljapur is poised for expansion of teaching, research and outreach programmes in the 12th Plan period.

The PGD WASH Programme is coordinated by CWPRG and conducted at the School of Rural Development, TISS, Tuljapur.



POST GRADUATE DIPLOMA PROGRAMME IN WATER, SANITATION AND HYGIENE

The water and sanitation plays a key role in the human wellbeing and overall development of any society across the globe. It is inherent part of the development agenda for developing country like India where millions even today lack access to basic water and sanitation services. Achieving universal sanitation i.e. access to basic water and sanitation services have been identified as one of the key targets according to Millennium Development Goals (United Nations). Central rural sanitation programme (CRSP) launched countrywide Total Sanitation Campaign (TSC) programme in 1999. For effective implementation of the programme the state government have created special cells/units at state and district level. The primary aim of these institutional arrangements is regular monitoring and supervision of various sanitation programmes. Recently the Government of India has also introduced a Rural Sanitation and Hygiene Strategy with the objective to create Nirmal Bharat by 2022 under Nirmal Bharat Abhiyan.

UNICEF in partnership with the Water Supply and Sanitation Department (WSSD), Government of Maharashtra, conducted a Training Need Assessment of District Sanitation Managers in year 2010. The comprehensive assessment covered all 104 Total Sanitation Campaign (TSC) Cell consultants on almost entire range of technical skills. Other emerging training needs include specific inputs related to motivation, project management, documentation, planning and monitoring. The findings of TNA once again brought to forefront the need for quality professionals having exposure to both technical and non-technical aspects. In the past UNICEF has actively supported the training programmes in the WASH sector, this led to realisation that there is need to shift from routine training programmes for sustained capacity development. Accordingly UNICEF initiated discussions with TISS, WSSD and civil society organization. The findings helped reach consensus that it is difficult to achieve the goals of water and sanitation without creating fresh cadre of WASH professionals and building commensurate capacities of the in-service officials in terms of skill, knowledge and attitude.

Based on this WASH section Mumbai and TISS jointly adopted the curriculum of India's first course PG Diploma on WASH. The diploma programme has been designed with specific intention to fill this crucial gap which inhibits the progress of water and sanitation programmes in India. The broader objective of the course is to develop a cadre of professionals with scientific and social skills to effectively manage WASH sector and it's services.


Field Work - Our USP




- * Through the field work, the students can learn how to apply social work methods in the situation of given individuals, groups or communities problems.
- * The students achieve self-awareness and discipline to use them as a helper and as agent of change in an individual and group situation.
- * It helps the students to apply the developmental theories and principles of WATSAN into actual practice.
- * The students acquire practical knowledge and are given an opportunity to try variety of development and social work methods, skills and techniques.
- * The students become familiar with administrative procedure and process of Organizational Development. They learn how to run an office, what kind of routine needs to be established, how to facilitate administrative arrangement, relevant to the discharge of the responsibilities of their own assignment.
- * The students have an opportunity to learn the organizational framework of services. They understand the structure and policy and how to facilitate such policy through practice. They become familiar with different institutional styles & tempos of agencies associated with various field practices.






